Appendix 3C: Property Impacts

Wasatch County parcel data as of April 2025 were used to determine potential property impacts by alternative. The county parcel data do not have complete owner and property address information for the project area.

The parcel data, as they are maintained by the County, do not align well with the actual locations on the ground, especially along US-40. Because of poor parcel alignment, the property impact tables should be viewed as an approximation only.
